I believe you have a Christian duty to resign from the ASA to protest the conduct of the leadership of the ASA because this organization is supporting the refusal of the American Journal of Physics (AJP) to retract the attached article about evolution and the second law of thermodynamics. I've also attached a peer-reviewed article of rebuttal. I believe you are both involved with publications of the ASA, which has rejected my article explaining why the AJP article is absurd.

In a nutshell, creationists have the incorrect but intelligible idea that biological evolution violates the second law of thermodynamics, according to which a cube of sugar dissolves in water but does not un-dissolve. Creationists are confusing a sugar cube, which is a collection of molecules, with a protein, which is a single molecule. The AJP article refutes this error with the unintelligible proposition that evolution does not violate the second law of thermodynamics because of the sun. The article supports this nonsense with a calculation using an equation that describes the second law of thermodynamics.

This is a matter of national concern because it undermines the integrity of science and promotes misinformation about evolutionary biology. A staff member of my congressman (Yvette Clarke, D-NY, 9th district) told me that my allegation against the AJP was being investigated. My correspondence with Clarke is at

The behavior of Randy Isaac is particularly blameworthy and shows how important it is for the AJP to retract the article. When I started posting on the Forum of the ASA, Randy offered to "walk me through" the second law. He was obviously being sincere at first, and assumed I was a creationist or advocate of intelligent design and did not have a Ph.D. in physics. His responses to my explications of the matter soon became inane. I asked Robert Kaita to assign a moderator, but this request was ignored.
